- ▶ The George R. Corey–Linda M. Gemello Award was endowed by Joe Cotchett and Cotchett, Pitre & McCarthy in honor of George Corey and Linda Gemello, leaders of the San Mateo County legal community who were deeply committed to Legal Aid SMC’s mission. This year’s George R. Corey–Linda M. Gemello Award is presented to Amira Elbesheshy, Directing Attorney of Legal Aid SMC’s Health Consumer Center.

Amira took an unusual path to her career as a legal aid attorney. After graduating from Fordham University School of Law, Amira worked as a civil litigator for the New York City Transit Authority for several years. She then changed direction, moving to California and earning a Master of Social Work in Mental Health and Wellness from the University of Southern California. Before Amira came to Legal Aid SMC in 2018, she had been working as a Clinical Case Manager at Alameda Family Services, helping clients access affordable housing, health insurance, food, and other basic needs. She joined Legal Aid SMC’s Health Consumer (HCC) to pursue similar goals with a different set of tools: using her legal expertise to help people get the health care they need.

Amira’s leadership potential was evident from the start, and she was promoted to Supervising Attorney and Director of the Health Consumer Center after serving as a Staff Attorney for just over a year. In February 2022, Amira was promoted to Directing Attorney. She leads a strong team that helps San Mateo County residents get affordable health care and advocates at the local and state levels for policy changes to improve access to health care. The HCC is often asked to weigh in on health policy issues impacting millions of Californians.

Amira is a terrific lawyer, easily mastering complex Medi-Cal concepts like spousal impoverishment and presenting carefully crafted legal arguments to hearing officers and policymakers. What stands out most to those who work with Amira, though, are her exceptional interpersonal skills. Amira is that person everyone in the office goes to for advice. She never dominates a meeting, but when she speaks up, everyone listens. Her insight into how people relate to each other makes her a strong advocate and a valued colleague.

In recognition of her commitment to health care for all, Legal Aid SMC is honored to present Amira Elbesheshy with this year’s Corey–Gemello Award.

THE GUARDIAN OF JUSTICE AWARD

She has been working with Legal Aid SMC since 2020. Deborah is a native San Franciscan. She received her J.D. from the University of San Francisco School of Law.

Deborah has taken on 13 Legal Aid SMC cases, including domestic violence restraining orders, guardianships, and conservatorships. She worked on guardianships for five children who lost their parents, which was featured in our pro bono newsletter. Clients highly praise her excellent work and professionalism.

From the moment we met, Deborah has been a constant and dedicated pro bono, taking 13 cases since our first meeting. Coastside Hope
Neighbors Helping Neighbors

- ▶ “Necessities for today, opportunities for tomorrow” is the guiding principle driving the programs and services at Coastside Hope. Established in 1976, Coastside Hope’s mission is to provide necessities to enhance the quality of life for its neighbors in Half Moon Bay, El Granada, Moss Beach and Montara. Coastside Hope provides necessities like food, clothing, housing assistance, online applications for government benefits, referrals, it provides opportunities through citizenship classes, tax preparation services, and connections to other organizations. With a small team of nine employees Coastside Hope helps over 3,500 individuals every year – more than 14% of everyone living in its service area. Coastside Hope’s vision is to create a strong community where all neighbors prosper together.

Coastside Hope Executive Director Judith Guerrero was born in Jalisco, Mexico and has called Half Moon Bay home for over 25 years. She has amplified Coastside Hope’s impact in the community and navigated the organization through one major challenge after another. She led Coastside Hope in supporting CZU fire evacuees, mobilizing a safety net for 200 displaced workers following the abrupt closure of a legacy nursery, exposing a hemp farm for withholding wages from farmworkers, keeping Coastside Hope’s doors open throughout the pandemic, and providing extensive, daily support to the individuals and families displaced by the mass shooting event on January 23.

“Coastside Hope has been an indispensable partner to the LIBRE (Linking Immigrants to Benefits Resources and Education) program for many years. Their location helps us connect with residents on the coast, many of them Spanish speaking farmworkers, where access to benefits and services is limited. They were instrumental in providing essential services to those affected by the tragic shootings in Half Moon Bay and the winter storms. HELPING A GRANDMOTHER PROVIDE A STABLE HOME FOR HER GRANDSON

Mary was unable to care for her child as she would have liked to and agreed that her mother, Brenda, would be the best caretaker. The loving grandmother agreed to take on guardianship for her newborn grandson.

Brenda came to Legal Aid SMC for assistance obtaining legal guardianship of her newborn grandson, which can be a complex process. Fortunately, a team from Morrison & Foerster — Partner Anita Choi, Lead Scientific Specialist Evangelina Lopez, and Associate Emily Voytas — were there to assist her. They made a long-term commitment to the “incredibly kindhearted, loving grandma” and her grandson.

In 2018, the team from MoFo secured guardianship, allowing the grandmother to care for her grandson. Shortly after, Brenda returned to Legal Aid SMC and asked if the same team could help her adopt her grandson, furthering his sense of security in her home. Despite being new to the area of adoption, the team jumped in and agreed to work with Brenda again, ensuring that she could care for her grandson throughout his childhood.

“After many bumps in the road (and an inconvenient pandemic that delayed matters), the adoption was finalized. This was such a happy day for the client and her family. We thank Anita, Evangelina, and Emily for their hard work and dedication to this special family.





CLIENT STORIES

▶ HELPING A SENIOR NAVIGATE THE SOCIAL SECURITY SYSTEM

Minh's 92-year-old mother, Linh, had her SSI (Supplemental Security Income) benefits suspended because the Social Security Administration (SSA) alleged that she had too many assets to qualify. She was accused of having \$460,000 in assets due to the sale of her late husband's gas station, but the debts on the property exceeded the proceeds. Linh had signed over her share of the proceeds to cover the liabilities. Worrying about her finances and the hardship it placed on her family caused Linh unbearable stress.

Knowing her mother did not speak English, Minh took on the task of finding help. They searched for assistance but were unsure what services they needed in their situation. With the deadline to respond looming closer, Minh finally found and contacted Legal Aid SMC's Senior Advocates program.

"The lawyer was amazing and spent the time with us reviewing, preparing, and submitting legal documents," Minh reported. "He was the best and the only one that was able to help and with a very short turnaround time. I know he worked at lunch hour and had to work very hard to get the paperwork done on time." When Linh received the letter that her SSI benefits would be restored, she said, "The family is okay now."



▶ HELPING PARENTS CARE FOR THEIR ADULT CHILD AT HOME

Cristian, a 22-year-old with cerebral palsy, epilepsy, lung disease, and other disabilities, needs the nursing care he has relied on for years to live safely at home with his parents. The nursing care was covered by a health insurance plan through his father's employer. But when the employer changed plans, the new insurance company decided that Cristian did not require that level of care and stopped paying for it. The family appealed this decision but were denied. That's when they turned to Legal Aid SMC's Health Consumer Center (HCC).

An HCC attorney gathered support letters from Cristian's specialist physicians affirming his need for nursing care. With help from Cristian's family, the attorney submitted another appeal to the health plan. When the plan denied their appeal, their attorney helped them file for an independent review. The reviewer agreed with Cristian's specialists that nursing care was a necessity, condemned the plan's analysis, and approved Cristian for nursing care.

Cristian and his family were relieved by the huge victory, which allowed them to continue caring for Cristian safely at home. The family could not have afforded the \$5,000 to \$10,000 monthly cost of nursing services. "Due to his delicate physical condition, it is very important for Cristian to have professionally trained personnel providing the proper care for him," Cristian's father shared. "My wife, my son, and I are so appreciative of the [effort] you have shown in this matter. Thank you very much for all your help."

Despite the difficult circumstance, the family remained incredibly gracious and kind throughout the entire appeals process. Legal Aid SMC is humbled to have worked for the family and pleased that the appropriate caregivers have been assigned to Cristian's case.
